(This translation is to be used solely as a reference to aid in the understanding of the usage guidelines. For all purposes of interpreting and applying law to any legal issue or dispute, users should consult the original Japanese text)

1 Basic Management Information

2 Main Information Distributed

Posts which contain the following are prohibited. Any such posts will be deleted without warning.

(1) Illegal, or potentially illegal matters.

(3) Political or religious agenda.

(4) Infringements on the copyright, trademark right, and/or other intellectual property right of the Association or others.

(5) Advertisements, promotions, solicitations, businesses, or other commercial purposes.

(6) Discrimination or the promotion of discrimination based on race, thought, or creed.

(7) Threats to the public order or morality.

(8) Impersonations, falsehoods, misrepresentations, misleading information.

(9) Infringements of privacy, including the specification, disclosure, or leaking of personal information without the person’s consent.

(10) Content that includes malicious software.

- (11) Obscene or inappropriate content.
- (12) Spam, or successive postings by the same user within a short period of time.
- (13) Any other information deemed inappropriate by the Association.
- (14) Inclusion of links that feature (1) – (13).
